Position Summary: The Graduate Assistant position is with the Counseling Department for Fall 2025 & Spring 2026. Assistantships require a total of 399 hours for the academic year (Fall & Spring) which is equivalent to 6 credit hours (3 per semester). Due to the nature of this work, hours are not restricted to a standard 9a-5p schedule. This position assists the Counseling Department faculty and staff in the completion of an array of administrative, research, assessment, and teaching tasks. The position is a part-time position offered during the fall and spring semesters (mid-August through mid-May).

Primary Responsibilities:

- Creating, organizing, and running the Spring Intensive event.
- Assisting faculty with course-related needs (e.g. grading assistance, rope course, equine activity, guest lecturing/classroom coverage, etc.).
- Assisting with conducting research.
- Assisting with locating, applying for, and conducting work associated with grant funding for the department and CWC.
- Other duties as assigned.

- Strong working knowledge and understanding of established professional codes of ethics and best practices in multicultural and social justice counseling and research.
- Demonstrate commitment to promoting inclusiveness and cultural competence.
- Outstanding verbal, writing, and presentation skills; must be able to communicate and interact effectively with MMU students, employees, and alum.
- Exceptional ability to multitask and prioritize projects.
- Excellent oral, written, and interpersonal communication skills, including the ability to work with diverse groups, facilitate group processes, and foster collaborative decision-making.
